

Minutes of the March 7, 2000 General League Meeting

The Muscle Shoals District Service League met at 7 p.m. on Tuesday, March 7, 2000, at the Florence Conference Center. President Kathy Gamble called the meeting to order. President-Elect Lisa Ruggles began the meeting by informing the membership that Member Cheryl Ford had been seriously involved in an automobile accident over the weekend and provided details of her condition.

Roll -- 78 members were present and 40 members were absent with 12 Provisionals present and 4 absent.

Minutes – Upon motion and a second, the February General Meeting minutes were approved unanimously.

Admissions – Admissions Chairperson Paige Cates reviewed the procedures for admissions and the related deadline of April 1. She provided admissions applications and her cell phone should she be needed by anyone – 335-2801.

Treasurer's Report - Treasurer Deborah Fraser reported the following balances:

Administrative - 203.26 Community - 34,367.98 Memorial - 215.10 Total - 34,286.34

Correspondence — Corresponding Secretary Monica Marthaler reported that the League had received thank you notes to the provisionals for their help with the CP Telethon and from the Richard Holloway family for the sympathy flowers. Forty-nine letters relative to absences and other items were mailed to members. It was announced that Change of Membership Status letters were due to Recording Secretary Renee' Vandiver by April 1.

Other Business — Money was collected to cover the sympathy flowers sent to the Richard Holloway family and monies collected above the flower arrangement cost will be provided to the memorial of the family's choice.

Officer Elections – Kenda Rusevylan moved approval of the proposed slate of officers and Melissa Self seconded the motion. The motion was approved unanimously.

COMMITTEE REPORTS

Apple Annie – No report due to the absence of Chairperson Penny Joiner.

Attention Homes – It was reported that donations were made to the Attention Homes as follows: February - \$45.75 and March - \$24.96.

Cookbook Treasurer – Chairperson Allison Newton reported that after the March payment is made, the cookbook balance will be zero, which paid off the cookbook in 22 months. However, \$9,700 is owed to the League and a loan will be obtained in order to repay that amount.

Cookbook - Chairperson Allison Newton provided the following details about the Spring Spectacular Luncheon and Fashion Show: 11:30 a.m. on Saturday, April 15 at First Presbyterian Church; the \$25 ticket includes the Art of Cooking Cookbook; only 160 tickets are available for the event and they will be available to members at the meeting; March

21 is the deadline for turning in tickets or the money for the tickets or members will be obliged to pay for the tickets; the retailers who are participating in the event were announced; Dawn Hilliard of Bill's Florist will be making a floral presentation during intermission; the tickets and programs were all donated by League member Lari Collier; the tickets are a two-part ticket in which the top is given to the purchaser and the League keeps the second part and the League member who sells the ticket writes her name on that part of the ticket and obtains credit for the sale of a cookbook; the table arrangements, underwritten by various businesses, will be given as door prizes; the menu was provided; it is hoped that the event will cost no more than \$500 and that most of the costs can be covered by donations; and various thank you's were given.
