What is BAB?

A huge, bi-annual rummage sale from thrift collected from League members, sustainers, and friends of MSDSL. The first BAB was held in March 2001 and replaced the Follies, a long-running fundraiser for the League. The MSDSL has been able to distribute approximately \$70,000 generated by BAB to community agencies and organizations. This fundraiser helps in several ways:

- People in the community are able to buy quality items for reasonable prices.
- MSDSL is able to distribute MORE funds (in addition to Apple Annie) to our community.
- Best of all...Closets, garages and drawers are CLEANED OUT!!!

Kick-Off Party!

In the past, the Silent Auction/Preview Party was held the night before the sale at the sale site. This year, the Kick-Off Party will be held a week or two before the sale day, at a different location. This way, ALL can enjoy themselves and not have to worry about getting up the next morning at 5:30am! The party WILL be open to friends of MSDSL (\$20pp) and there will be a silent auction. There will be food, live entertainment and a "BIG GROGAN'S SURPRISE," so bring yourself, friends and your wallet and enjoy a night out! (Location and date TBA) Responsibilities of Each Member:

Each member must:

- Turn in \$75 worth of thrift (only \$15 worth of adult clothing is allowed toward thrift quota).
- Each member must work a 3 hour sale day shift.
- Each member must work a 3 hour work shift.
- Each member will serve on a BAB committee, which will include up to 3 additional hours of service.
- Thrift may be stored (already priced and tagged) in our storage unit behind Parkway City Mall on 11/13 and 12/4 from 9:00-10:00am. Please remember that items will NOT be checked in at this time.
- There will also be a Thursday night drop-off dates beginning in January at the BAB sale site (if possible). These dates will be given out at the January League meeting.

Prize Girl

This year there will be 1st, 2rd, 3rd top thrift producers. The reward will be as follows:

- 1*-the member who turns in the largest \$ amount of thrift will be excused from \$ale day and her work shift.
- 2nd-the member who turns in the next largest \$ amount of thrift will be excused from Sale day.
- 3^{rt}-the member who turns in the third largest \$ amount of thrift will be excused from her work shift.

If you are planning on being a prize girl, please let Karen or Rebecca know by January 15th. All prize girl thrift MUST be turned in by February 12th! NO EXCEPTIONS!!!

There are many more details that will be announced in the following months. The BAB committee thanks you in advance for your hard work! We know it may seem overwhelming and understand that it does require extra time and effort, but if we all work together and do our part, the benefits for our community will be enormous!
