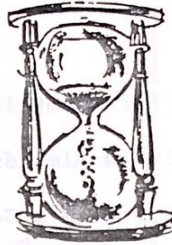

The Future Policies committee met on January 15, and voted to make the following recommendations to the general membership. These recommendations are to be considered and voted on at the March general meeting.

Constitutional Changes:

- 1) page 48, Article III, Section 1(a) - Provisional Membership
,,, "Based on the Provisional Director's report, the general membership will vote on provisional members at the May Luncheon."
- 2) page 50, Article IV, Section 1 - Annual Does
Delete the word "only".
- 3) page 52, Article V, Section 4(f) - Parliamentarian
Drop the office of Parliamentarian.
- 4) page 51, Article V, Section 4(c) - Recording Secretary
Add the duties of Parliamentarian to the Recording Secretary's duties.
- 5) page 53, Article VI, Section 1 - Board of Directors, Number and Term
"The Board of Directors shall consist of the 4 elected officers, the 3 appointed officers, Future Policies chairman, Finance chairman, Hour Glass chairman, Placement chairman, Apple Annie chairman, Admissions chairman, Cooks and Company chairman, Follies Directors, and 2 members at large (1 from each county)."
- 6) page 55, Article VII, Section 1(f) - Hour Glass Committee
"There shall be an Hour Glass chairman..."
- 7) page 58, Article IX, Section 3 - Bonding
"The President, Treasurer, and the Cookbook Treasurer shall be bonded."
