





The Future Policies committee met on January 15, and voted to make the following recommendations to the general membership. These recommendations are to be considered and voted on at the March general meeting.

Constitutional Changes:

- page 48, Article III, Section 1(a) Provisional Membership ,,, "Based on the Provisional Director's report, the general membership will vote on provisional members at the May Luncheon."
- 2) page 50, Article IV, Section 1 Annual Dues Delete the word "only".
- 3) page 52, Article V, Section 4(f) Parliamentarian

 Drop the office of Parliamentarian.
- 4) page 51, Article V, Section 4(c) Recording Secretary
 Add the duties of Parliamentarian to the Recording Secretary's
 duties.
- 5) page 53, Artile VI, Section 1 Board of Directors, Number and
 Term

 "The Board of Directors shall consist of the 4 elected officers, the 3 appointed officers, Future Policies chairman, Finance chairman, Hour Glass chairman, Placement chairman, Apple Annie chairman, Admissions chairman, Follies Directors, and 2 members at large (1 from each county).
- 6) page 55, Article VII, Section 1(f) Hour Glass Committee "There shall be an Hour Glass chairman..."
- 7) page 58, Article IX, Section 3 Bonding
 "The President, Treasurer, and the Cookbook Treasurer shall be bonded."

Operating Rule Changes:

- 1) page 58, Article XII, Operating Rules
 ... "The Operating Rules may be changed by a simple majority vote
 at any regular meeting, only after being published in the Hour
 Glass prior to the monthly meeting."
- 2) page 59, Article XII, 4.A
 Sick Leave or Career Leave: "A member may be excused from fulfilling her duties in case of prolonged illness or career
 opportunities. If illness or career opportunity extends over
 six months,"
- 3) page 59, Article XII, 4.B
 ... "Any member returning from maternity leave must, however, fulfill 2/3 of her remaining meeting requirements and 2/3 of her remaining Placement requirements."

- page 60, Artile XII, 7.C 4) Change the word "girl" to "member".
- page 60, Article XII, 7.E 5) Add exception: "Any member of the Association of Junior Leagues will be allowed to transfer her membership upon the first vacancy after verification of satisfactory membership with previous organizations."
- page 61, Article XII, 7.G 6) Provisional members will be asked to sell 1.5 cookbooks per year totaling 12 cookbooks at the end of her 8 years of service to the League. Refer to Operating Rule 17.A(4).

4. All provisionals must work on an Apple Annie Committee (Bags, Crates, or Office) assigned by the overall Apple Annie Chairman. Operating Rule 17.A(6).

5. All provisionals must work Plant Sales the day before Apple Annie Day.

All provisionals must work a 4 hour post on Apple Annie Day. If a provisional cannot fulfill her Apple Annie duties she will remain a Provisional until the following Apple Annie

8. Provisionals who have been on sick leave will continue on provisional membership until provisional requirements are completed.

- page 61, Article XII, H.4 "If an applicant is invited to membership but is unable to accept at the time, and asks that she be considered next year, her application can be placed at the top of the list for one year."
- page 62, Article XII, H.9 "Names of girls having been asked to accept membership will be 8) announced at the May Luncheon and those accepting membership will be published in the August Hour Glass."
- page 63, Article XII, 11 9) "The committee chairmen shall have meetings of their respective committees, and they shall plan with their respective committee Those committee chairmen who are not members of the members. Board of Directors, may notify the President when they have a report and come to the Board meeting to submit their report. If necessary, the report may then be submitted to the League membership for approval.
- page 64, Article XII, 17.A.1 Change "pantsuits" to "pants."
- page 64, Article XII, 17.A.3 Change "three Co-chairmen" to "two Co-chairmen."
- page 64, Article XII, 17.A Change 17A to be Cooks and Company cookbook, 17B to be Apple Annie Day, and 17C to be Follies.

13) page 64, Article XII, 17A

- A. Cooks and Company cookbook is an ongoing fund raising project sponsored by the Muscle Shoals District Service League.
 - 1. There shall be a chairman, an assistant chairman, a Treasurer, and other committee members as needed.
 - 2. The Chairman and the Assistant Chairman are appointed by the Executive Committee.
 - 3. The Assistant Chairman will assume the responsibility of Chairman the following year.
 - 4. All members, including provisionals, must participate in the sale of the <u>Cooks and Company</u> cookbook, by being required to sell 12 cookboos in their 8 years of service to the League, beginning with Provisional class of 1990. (All members prior to 1990, the number of books will be prorated for the remaining years of service, or 1.5 per year).
 - 5. Cookbooks may be checked out.
 - 6. Payment of cookbooks are due on or before April 30, a 5% interest charge per month will be charged on the unpaid balance. If payment is not met by the following September, the member will have to appear before the Board of Directors to explain her failure of payment. The Board of Directors will then decide on the appropriate action to be taken.
- 14) page 65, Article XII, 18.4
 "Each member will serve on a League Committee every year."
- 15) page 65, Article XII, 18.5
 Insert as 5 "Provisional members will not serve on a League
 Committee during their provisional year." Then renumber 5-10 to
 become 6-11.
- 16) page 67, Article XII, 19
- 17) page 68, Article XII, 20

 "Regular meetings" should read "May Luncheon" and omit "by
 Thursday noon before the meeting." Change "twenty-five cents to
 "1.00" Omit "or bills" in the last sentence.
