MSDSL GENERAL MEETING MINUTES -FEBRUARY MEETING FEBRUARY 7, 2001

The MSDSL held its board meeting at 7 p.m. on February 7, 2001, at the Badcock Building in Sheffield, Alabama (site of the Bag-a-Bargain Rummage Sale). Lisa Ruggles, President, called the meeting to order.

Roll: 98 members present and 16 absent; 19 provisionals present and 7 absent.

Minutes: Upon motion and second, the January meeting minutes were unanimously approved.

Treasurer: Stephanie Winborn reported the following balances:

Administrative: 4396.80

Community: 39261.83 (including some Bag-a-Bargain deposits)

Memorial: 215.10 Savings account balance = 290.96

Correspondence: Renee Vandiver indicated the League had received a thank you note from the American Cancer Society for the provisionals assistance with their Party with a Purpose.

Nominating Committee: Lisa Ruggles thanked the Nominating Committee for the slate of executive officers that has been proposed for the 2001-02 League Year.

Change of Status Letters: Lisa Ruggles reminded members from the 1993 provisional class that change of status letters were due to the Recording Secretary by April 1.

Admissions Forms: Lisa Ruggles reminded all members that Admissions Forms are due to Paige Cates by April 1.

Committee Reports

Apple Annie: Chairperson Penny Joiner reported that there will be funds in the amount of \$31,761 to disburse.

Cookbook Chair: Chairperson Allison Newton announced the cookbook promotions that would be done in conjunction with Bag-a-Bargain -- a display table will be set up at the Kick-Off Party, and an old-fashioned lemonade/popcorn stand would be set up at the Bag-a-Bargain sale.

Cookbook Treasurer: Cookbook Treasurer Jackie Darby reported that VISA and M/C are accepted for the purchase of cookbooks. She also reported that \$630 was made at the December Silent Auction.

Finance: Chairperson Becky McDaniel announced that the Finance Committee would meet at 6 p.m. on February 27 at Dale's Restaurant to consider requests for Apple Annie funds. Requests for Apple Annie funds total \$71,181.60.

Future Policies: Katie Bendall announced that the proposed changes as published in the HourGlass will be voted on at the March meeting. Hospitality: No report.

Hourglass: Tonya Southall reported that the next deadline is February 15, 2001.

Placement: Chairperson Simone Mitchell distributed extra copies of the Mid-Year Placement Questionnaire and encouraged all members who had not done so to complete a questionnaire. Simone asked the Placement Advisors to meet following the League meeting.

Public Relations: Chairperson Pam Andrews explained the public relations work that was being done relative to Bag-a-Bargain. She reminded her committee to deliver their packets to her by Friday.

Provisional Directors: The provisional directors reported that the next provisional meeting would be held on February 20 at the Badcock Building. The CP Telethon and Special Olympics Banquet would be covered.

Rehabilitation: In the absence of Chairperson Sabrina Eddins, no report was made.

Scholarship: President-Elect Lisa Mathews reported on the balance available in the scholarship fund. She reported that Courtney Carpenter, the current scholarship recipient, is scheduled to graduate in May, so the Scholarship Committee will have to appoint a new recipient. It was reported that it appears that the League can function in the scholarship fund for another four years without having to deposit any additional funds.

Yearbook: No report.

Transportation: It was announced that approval had been granted by the Board for taking \$600 from Apple Annie funds and placing into the Transportation fund in order to grant requests for the remainder of the League year. There were four requests in January with a balance of \$178.30 with YTD requests of \$1,321.70.

League Development: Lisa Mathews thanked those members who had been slated for Executive Committee offices for next year for agreeing to serve in those positions.

Bag-a-Bargain: Bag-a-Bargain packets were distributed to all members. Each chairperson reviewed the information pertinent to their position (i.e., Kick-Off Party, Scheduling, etc.). Everyone was reminded that the deadline for RSVP to the Kick-Off Party is February 23. The Prize Girl deadline has been extended to March 3.

Proposed By-Laws pg. 89- Section 3.

a. Number and County

Change one hundred seventy (170) to one hundred fifty (150)

b. Proposal of members. <u>Leave out last sentence</u> about "provided however, that no member of the Admissions committee may sponsor any candidate."

pg. 91

Article III Dues

Add Section 3. Transfers. Any member shall be required to pay annual dues to the Muscle Shoals District Service League upon approval of transfer from a Junior League or other similar organizations.

pg. 93

Article IV Board of Directors Section 1. Number and Terms. <u>Add Transportation/Attention</u> <u>Home to the Board</u>

Proposed Operating Rules I.Membership

pg. 103

Section 1. Membership Numbers.

A. Ratio. The very end of the sentence where it says "first county by more than ten" change "ten" to "twenty-five"

B. Add Number. "The number of invitations for membership will be determined by the number of available positions for each county plus an additional 33%. The resulting number should by rounded down. In the event that, after all acceptances and declines are counted, there is a total number greater than the total number of members, as specified in the Bylaws, the following year's invitations will reflect the overage."

This will compensate for rejections to membership and will allow the League to extend only one round of the invitations. "This is a statistically valid procedure based on the previous three years of admissions."

pg. 105 and 106.

Section 2. Admission

D. Transfer Members. The very end of the sentence on page 106 where it says "Service and fundraising requirements for that year". Add this statement: "Transfer members must pay Muscle Shoals District Service League Annual dues upon approval of her transfer."

pg. 116

II. Fundraising

Section 2-A. Officers

Make Office Coordinator and Membership Coordinator one job so it would be called Office/Membership Coordinator

Section IV. Fiscal Policies

Section 2.

Annual/Income Tax Return. After the sentence "and will make it available to any member upon request." Add the line, "The Muscle Shoals District Service League is an approved 501 (C) (3) organization. Because of this status, the league is required to file a 990 Income Tax return, no later than the 15th day of the 5th month following the League's Fiscal year ending on May 31st. The income tax return must be filed by October 15th."

Section 4. League Funds.

Replace all instances of the word "accounts" with the word "funds".

pg. 122-C. Community Fund. Omit the words "follies funds".
