Minutes of the April 4, 2000 General League Meeting

The Muscle Shoals District Service League met at 7 p.m. on Tuesday, April 4, 2000, at the Florence Conference Center. President Kathy Gamble called the meeting to order. President-Elect Lisa Ruggles provided an update on the condition of Member Cheryl Ford, who had been seriously involved in an automobile accident last month.

Roll – 86 members were present and 29 members were absent with 14 Provisionals present and 2 absent.

Minutes – Amy Darby made a motion and Jackie Darby seconded the motion approving the March General Meeting minutes, which were approved unanimously.

Treasurer's Report – In the absence of Treasurer Deborah Fraser, Renee' Vandiver reported the following balances:

Administrative - -904.69
Community - 33,166.47
Memorial - 215,10
Total - 33,476.88

Correspondence - No report.

#### **COMMITTEE REPORTS**

Provisionals —Provisional Directors Lisa Keys-Mathews and Melissa Self introduced each provisional who provided detailed information on each placement that the League supports and they then presented EACH member with a "thank you" gift bag for all of their hard work and dedication. The gift bag contained imprinted MSDSL pens, candy, etc. This was a first in the MSDSL to date. The membership was quite surprised and impressed!!

Finance – Chairperson Penny Westmoreland reported requests for Apple Annie funds. These requests are indicated in the attachment provided in the March HourGlass but are contained in the full minutes on file. Specific actions were as follows:

Upon motions, seconds, and a unanimous vote, the following requests, as recommended by the Board of Directors, were unanimously approved: requests #1-7, 9-11, 13-16, 18-19, 21-30.

The following actions were taken on the remaining requests:

#8, request for \$2,400, Board recommended \$2,400 - because of the decrease of use of

Transportation funds during the 1999-2000 year, a motion was made, seconded, and unanimously approved to amend the Board's recommendation to \$1,500.

#12, request for \$300, Board recommended \$0 funding – because of the decrease in funding from #8 above, a motion was made and seconded to fully fund this request. Motion failed by a vote of 29 for, 39 against.

#17, request for \$1,094, Board recommended \$579 funding – because of the decrease in funding from #8 above, a motion was made and seconded to fund \$1,094 of this request. The motion passed with two oppositions.

#20, request for \$500, Board recommended \$200 funding – upon a motion and a second to uphold the Board's recommendation, the motion carried with two oppositions.

Following action on all requests for Apple Annie funds, \$385 remained for distribution. Upon a motion and a second to fund \$385 additional monies to the Children's Museum (#5), the motion failed. Upon a motion and a second to fund \$385 toward the Summer Enrichment Program (#25), the motion passed.

MSDSL Budget – Upon a motion and a second, the proposed 2000-2001 Budget as printed in the HourGlass but revised in the Apple Annie distributions was approved unanimously.

Apple Annie -- No report.

Attention Homes – A basket for the Attention Homes donations was distributed among the membership and collections will be reported at the May meeting.

Cookbook -- Chairperson Allison Newton provided final details about the Spring Spectacular Luncheon and Fashion Show that will be held on Saturday, April 15 at First Presbyterian Church. The Easter Basket raffle was won by member Julie Wilson.

Future Policies – Chairperson Katie Bendall reported that a meeting of the Future Policies Committee to consider additional changes would be held at 5:30 p.m. on April 10 at the Sheffield Public Library.

Hospitality – Chairperson Sabrina Eddins announced that the May Dinner would be held on May 2 at Dale's Restaurant at a cost of \$20 per member. Members must personally call Sabrina Eddins or sign a regret sheet that was distributed at the meeting or the member will be charged for the meeting.

Hourglass - Next deadline is April 16.

Placement — Chairperson Lisa Waldrep announced that (1) Placement Brochures would be available to the membership following the meeting, and (2) if you, as a member, have not been contacted by a Placement Advisor by April 14, you should call your placement advisor to make your desires known for next year's placements.

Public Relations - No report.

Special Olympics Banquet – In the absence of Missy Hibbett, President Kathy Gamble provided details about the upcoming Special Olympics Banquet.

Scholarship - No report.

Transportation — Chairperson Susie Ray reported that there were 3 requests in the amount of \$85 for Lauderdale County leaving a balance of \$570.30 in the account.

 already in place:


