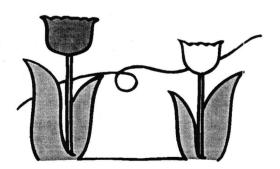

#### Dear League Members,

This is our proposed budget for the 2005-2006 fiscal year. Included in this budget is an itemized list of administrative expenses as well as projected inflows and outflows. Our goal is to make the budget process transparent so that every member knows precisely how and where we spend the money entrusted to us. For the second year, we have budgeted taking 20% of net profits of our major fundraisers to help offset administrative costs and training and educational expenses. According to our accountant and AJLI, this is in line with nonprofit organizations around the country. Please note that because this is a one-fundraiser year, we are in the planning stages of an **optional** community-wide social/small fundraiser to celebrate our transition into JL.
