

MINUTES OF THE OCTOBER 5. 1999 GENERAL LEAGUE MEETING

The Muscle Shoals District Service League met at 7 p.m. on Tuesday, October 5, 1999, at the Florence Conference Center. President, Kathy Gamble, called the meeting to order. The September meeting minutes were approved as written in the Hourglass.

ROLL There were 96 active members and 18 members absent with 16 provisional members present and 3 provisional members absent.

TREASURER'S REPORT

CORRESPONDENCE

Corresponding Secretary, Monica Marthaler reported that five letters for baby leave, 1 letter for medical leave, and 2 resignation letters had been sent. Monica reported that there were several thank you letters from various agencies posted on the correspondence board.

ADMISSIONS

Admissions Chairperson, Paige Cates was presented to conduct Admissions Committee elections to fill six positions on the Admissions Committee which were vacated by persons whose term on the committee expired. Balloting began and results were announced as follows: Lauderdale County: Penny Joiner, Lisa Matthews, and Susie Ray; Colbert County: Dana Lindsey, Mary Marshall Van Sandt, and Mary Ann Whitlock.

COMMITTEE REPORTS APPLE ANNIE

Apple Annie Overall Chairperson, Penny Joiner announced the following: Pre-sales deadline of October 19 with sales to be called in to the Bag Chairpersons, for Lauderdale County-Janice Pride and for Colbert County-Dana Lindsey; any member who could not be present for Polishing Party or Apple Annie Day should speak with Penny immediately; sales goals are 2,550 bags, 350 crates and 200 half-crates; prices are \$5 for 1 bag, \$35 for half crates of 40 apples, and \$50 for full crate of 80 apples. Members are to pick up crate cards and decals following the meeting; members are to place the decal on their car tonight and remove it on the evening of Apple Annie Day; red tights will be available at Parisian by mid-October; Apple Annie office will be housed at E.A. Nelson near O'Neal Bridge; office hours are 4-5 p.m. on Thursday, November 4 and 7 a.m. until -- on Friday, November 5; Polishing Party will be held at 1 p.m..on October 31 at the Muscle Shoals Recreation Center and members must sign in upon arrival; if any member cannot be present at Polishing Party, they must make arrangements for their pre-sold apples to be picked up; bring a rag to polishing party (clean socks work well); place dummy sheets at your place of employment to encourage pre-sales; bring crate cards and any money to Polishing Party; all money is due on Apple Annie Day; sale requirements are 12 bags and one crate or 12 bags and 2 half-crates or 25 bags; there will be prizes for top sellers in each county; the crop of apples is great

this year with prices remaining the same with the exception of the green and yellow apples which are more expensive this year; the green and yellow apples are available if persons insist but the sale of these apples is not encouraged because of the more expensive cost.

ATTENTION HOMES

A bag was passed around to collect monetary contributions for the Attention Homes to pay for their day-to-day operations. It was announced that the Executive Committee voted that all the money collected at League meetings for the Attention Homes will be given to Treasurer, Deborah Fraser, who, in turn, each quarter will issue a check to the Attention Homes. This way, the League won't be handing cash over to an agency and for reporting purposes, the Attention Homes will be able to document a donation from the League.

Chairman, Allison Newton reported that the raffles held at Women's Expo raised \$67. In an effort to make the availability of the cookbook easier for League members, Allison announced that two new locations were being used for obtaining cookbooks. Homemade Heaven in Muscle Shoals and Macy's Market in Florence. Allison was eager to report that in four weeks, the League went from having cookbooks in 22 businesses to 57 businesses. Allison reported that Patty Clement, whose recipe from Cooks and Company was selected to appear in the Hall of Fame Cookbook and was to have been at the October League meeting to accept her plaque and be recognized by the League, could not attend. Her plaque was shown to the membership. The Hall of Fame Cookbook can be purchased, and Allison Newton has the order forms should anyone be interested. Upcoming events where the cookbook will be sold are the UNA Festival of Trees and Christmas Open Houses at various florists and gift shops. Allison reported that Cooks and Company and The Art of Cooking appear in a new Cookbook Marketplace Catalog. The Cookbook Committee was asked to meet Allison following the League meeting. For Cookbook Treasurer, Heather Kimbrough, Allison reported the following balances: Checking Account \$323.82

Loan Balance \$17,765.40
Loan Payment \$3553.11

President, Kathy Gamble explained that the Executive Committee approved, which the Board ratified, a \$2,000 loan from the General Fund to the Cookbook Fund in order to make the September interest-free loan payment. The Executive Committee felt an in -house loan was better than obtaining a loan from the bank at this time. This money will have to be repaid to the General Fund because those funds are needed for operating expenses. It may be possible to borrow from Apple Annie funds for one of the payments but, again, those monies will have to be repaid for distribution to the community. Members are strongly encouraged to expend all efforts to sell the cookbook so that these payments can be made.

FINANCE

Chairman, Penny Westmoreland informed the membership that on November 1, applications for Apple Annie requests will be sent to area agencies on our list with a deadline of December 31 for receipt of those applications. If there are agencies who desire to request use of Apple Annie funds and those agencies do not appear on our list, members were asked to provide those names and addresses to Penny. For monies to be distributed to agencies, those agencies must have submitted an application by the deadline.

FUTURE POLICIES

Chairman, Katie Bendall asked that members provide to her any suggestions they may have for changes to the Operating Rules and Bylaws.

HOURGLASS The next deadline is October 13.

PROVISIONALS The next provisional meeting is for 6:30 p.m. on October 19 at the Northwest Alabama Rehabilitation Center.

PUBLIC RELATIONS

Chairman, Pam Andrews asked members to provide her with suggestions for any new ideas to promote Apple Annie Day. She asked members who personally know persons with businesses with marquees to contact those persons for use of their marquees in advertising Apple Annie Day. The Public Relations Committee was asked to meet with Pam following the League meeting.

REHABILITATION COMMITTEE

For Chairman, Susan Trousdale, Holly Nichols announced the fall party will be held on Oct. 8 from 9:30-1:30 at Gattman Park. Susan will be contacting committee members to work. Any donations would be appreciated.

TRANSPORTATION

.Balances were reported as follows: Colbert County-\$400, Lauderdale County - \$104. No requests for this month.

YEARBOOK

Chairman, Angie Goode announced that Yearbooks would only be provided to members who paid dues.

Kathy Gamble announced that the Sustainer Luncheon would be held at 11:30 a.m. on October 12. The cost is \$12 and reservations should be made to Kim Mauldin by Thursday. The Provisional Directors, Executive Committee, Apple Annie Chairperson, and Cookbook Chairperson were asked to attend. The next League meeting (Polishing Party) will be held at 1 p.m. on October 31 at Muscle Shoals Recreation Center.

Parisian Charity Event - A motion was made calling for all members to support the Parisian Charity Event by selling 5 - \$5 tickets and bringing the \$25 to the Polishing Party. The motion failed by a vote of 45 to 64 against. A motion was made and seconded calling for members to sell tickets on a volunteer basis bringing any monies from the sale to the Polishing Party. The motion was approved.
