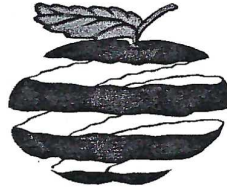

**MSDSL MEETING MINUTES –OCTOBER MEETING
OCTOBER 2, 2001**

The MSDSL held its board meeting at 7 p.m. on October 2, 2001 at the University of North Alabama. Lisa Keys-Mathews, President, called the meeting to order.

Roll: 86 members present and 32 absent; 41 provisionals present and 7 absent.

Minutes: Upon motion by Mary Marshall Van Sant and a second by Amy Darby the minutes from the September meeting were approved unanimously.

Treasurer: Penny Westmoreland reported the following balances:

Administrative:	\$ 4,664.78
Community:	2,590.72
Memorial:	215.10
Checking Account Balance	7,450.60

She reminded members that our \$55.00 league dues are due November 15, 2001 and that the late fee is \$15.00.

Correspondence: Penny Joiner reported that the league received thank-you notes from Rolling Riders, Lauderdale County Schools, Kids' Playground, Adult Basic Education, and the Alabama Institute for the Deaf & Blind.

Other Business:

- Lisa Keys-Mathews announced that a collection would be taken at tonight's meeting for Todd Foust's scholarship fund at UNA.
- Lisa Keys-Mathews informed members that nametags must be worn on Apple Annie Day and that they must inform Dana Lindsey tonight if they need a new one by Apple Annie Day.
- Upon the board's recommendation, a motion was made to have Bag-A-Bargain in the spring of 2003. The motion carried by a unanimous vote.

League Development: Allison Newton introduced Alison Isbell, director of the CP Center in Sheffield, as the guest speaker. She informed the league about the center and their services to the public. Alison also thanked the league for funds the center receives to purchase equipment.

Committee Reports

Apple Annie: Chairperson Mary Marshall Van Sant reminded the league about Apple Annie dates: Polishing Party – Sunday, October 28, 1:00 p.m. at the Muscle Shoals Recreational Center (remember to bring a cloth); Plant Sales - Thursday, November 1; Apple Annie Day, Friday, November 2. The office will be at Woodward Avenue Baptist Church, and all money will be due on that day. The office will be open on Thursday from 3-5 p.m. and on Friday from 7 a.m. until. Lynn Bevis announced that Apple Annie t-shirts were available in the lobby for \$5.00 and that there are enough for everyone to buy one. Top sellers will leave first and there will be a check-out this year. Presale deadline is Tuesday, October 16. Patty Klos suggested that we might donate a portion of our Apple Annie funds to the Red Cross for the disaster relief.

Cookbook Chair: Chairperson Lori Dolan reported 14 people submitted cards for the drawing. Molly McCanless won the door prize. She encouraged members to continue to give her names of businesses willing to sell cookbooks.

Finance: Chairperson Becky McDaniel requested that members give her names and numbers of agencies interested in Apple Annie funds. She announced the deadline of December 25, 2001 for requests.

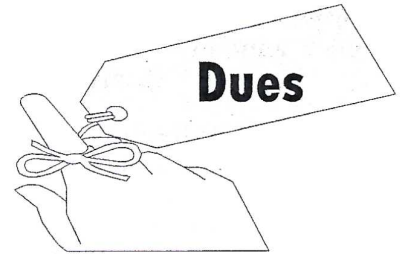

Stephanie Banks is a 2nd grade teacher at Southside Primary School. She is married to Mark.

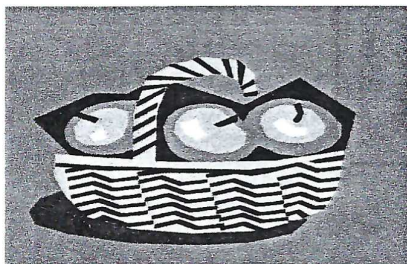
Susan Webb is married to Burt and is a stay at home mom to Jones Taylor-3mon. She enjoys tennis, snow-skiing and is a registered nurse.
